## Curriculum and Instruction Update

Mrs. Gallagher reviewed the mathematics and science STAR results shared at the previous meeting. The English-language arts results showed an increase with 92% scoring at proficient or advanced. The writing performance for seventh grade students showed 97% scored at proficient or advanced. The same cohort scored only 52% at proficient or advanced in fourth grade. Due to budget cuts, the writing test was not administered to fourth grade students this year. The updated English-language arts materials include new English language development and intervention components. Training on the new components will begin next week.

Curriculum and Instruction Update (continued)

The results of the history-social science test administered to eighth grade students showed 89% scoring at proficient or advanced.

Mrs. Gallagher reported the district's Academic Performance Index is 965. Information on the Academic Yearly Progress will be presented at a future meeting.

PTA Goals for 2010-11

Elena Shea, Los Altos Mountain View Council President, shared PTA is a volunteer organization working on behalf of schools to improve education, health and welfare. Their main three goals include supporting education in schools, community building and fundraising. She introduced the school presidents who highlighted their 2010-11 school goals: Sheila McGovern, Special Education, continue to create a more inclusive and supportive community, increase enrichment opportunities and continue to work with the district to improve the special education program; Jean Limbach, Almond School, enhanced communications with an updated website and the addition of classroom websites, create volunteer positions to sustain technology and work on the reporting systems; Elizabeth Maciag, Blach School, continue to fund zero period for students needing additional assistance, online communication, technology support and updating software standards; Suzanne Thomas, Egan School, community support for Go Green, focus on physical fitness, technology support; Mary Healy Jonas, Gardner Bullis School, continued community building, created a committee to improve communication and technology committee was formed to develop long and short term plans; Erin Eggleston, Loyola School, increased communication and technology committee was formed to develop long and short term plans as well as conservation of physical and volunteer resources; Ann Enthoven, Santa Rita School, community building and technology and Trish Fairbanks, Oak School, continue the Project Cornerstone and Starting Arts programs, support the maintenance of the multipurpose room and technology.

Community/Schools Meeting Mr. Baier reported on the Community/Schools Committee meeting held on September 21. The plans for Rosita Park have gone out for bid. The city plans to install the hardscape and have the Parks and Recreation Department make the decisions on the play structure and equipment. Discussions also included the small playground at the rear of Covington School that needs upgrading. A shared use agreement with the city and the district would allow the school access to both playgrounds in exchange for sharing the cost of equipment and upkeep. The district discussed with the city the long-term possibility of expanding the use of Covington School and needing access to the school from Rosita. The city stated that would not be possible with the current plans.

Mr. Baier also reported discussions were held on the Blach area traffic study and the water district project. The city has offered to lend their expertise in helping with traffic during the construction of the water district project.

Mr. Smith reported on the allocation of crossing guards throughout the district. There is concern with the Edith Avenue and Foothill Expressway intersection. The city will report back to the district with absolute and relative allocations.

Mr. Goines reported on a home that is planned for redevelopment on the corner of Linden and Portola Avenues. The city was informed that the construction vehicles parked in that area could be hazardous to students walking/biking to Egan. The city will take that into account during the planning phase. The possibility of opening a rear entrance to Egan was discussed. It was determined the city owns a strip of land from the back of Egan to Kingswood Terrace that the neighbors have built on. Enrollment at the Egan site has gone from 500-600 students to over 1,000 students with BCS sharing that site. The city will look into this and report back to the district. At Santa Rita School students have been exiting through a gate at the back of the school and walking through a neighbor's yard to get to the back streets of the school. There is another gate along the property line of Pilgrim Haven that could possibly be used in lieu of the other gate. This area of Pilgrim Haven is not slated for redevelopment but the area the gate exits to may not allow for student traffic. Mr. Baier will discuss this with Pilgrim Haven.

Community/Schools Meeting (continued) MSC: Mr. Goines, Mr. Smith to request the city of Los Altos explore with the Los Altos School District a shared used agreement for the playgrounds at the Covington School side of Rosita Park and the Rosita Park side of Covington School to find a way to develop both of them for community and school use.

Proposed Water District Project at Blach School Mr. Kenyon reported the water district held a neighborhood meeting on September 21. At the meeting conceptual plans for the project was presented and public input was taken. The plans will be refined and may be available for review by the October 25 meeting. The board will need to continue studying the issues so they are prepared to make a decision in December or January. Ms. Logan shared the neighbors are concerned with safety, the turf field and the stability and placement of the slope for the basin.

Tom Campbell provided public input.

Parcel Tax Feasibility Task Force Mr. Baier reported Mr. Goines and Mrs. Harrigan attended the first meeting of the Parcel Tax Feasibility Task Force. The meeting focused on the campaign messaging based on the May 2010 survey results. Once the messaging is complete another survey will be performed to refine the information in a few areas and to help determine what the community would support in a parcel tax.

**Board Protocols** 

Mr. Baier reported at the meeting on September 20 discussions were held on board policies and bylaws involving district governance. At the meeting Mrs. Harrigan and Ms. Logan agreed to serve on a subcommittee to develop board protocols. Mr. Baier would like to formally call this adhoc committee.

Resolution #10/11-03, Allocation of Teaching Stations to Bullis Charter School Mr. Kenyon reported this resolution was shared with the board earlier but additional time was needed to finalize it. Mr. Smith shared some minor wording changes were made to the resolution. If the resolution is passed it will be sent to the BCS board for their vote. The resolution states the classroom loading numbers for BCS will be adjusted after April 1. If the numbers decrease the district will allocate the same amount of facilities in the preliminary offer, if the situation worsens then BCS agrees to accept a reduced offer of facilities. This would be a three-year agreement and a mediation clause is included.

Katia Kamanger and John Phelps provided public comment.

Senator Simitian will be at the Los Altos City Hall on September 30 at 6:30 p.m. for a Town Hall meeting. The board will be visiting Springer School on October 8.

BOARD AND ADMINISTRATION COMMENTS, UPDATES, QUESTIONS, ITEMS FOR FUTURE AGENDAS (continued) Mrs. Gallagher reported on September 30 teachers in grades 4 and 5 will be trained on a student data management system. The first district minimum day will be held on October 7. Teachers in grades K-5 will be trained in the updated English language development and intervention materials from Houghton Mifflin, grade 6 teachers will discuss the math diagnostic assessments and identify students for pre-algebra, the traveling teachers will be in inclusion training for drama, music and art and classified employees will receive training from Project Cornerstone on playground interactions. GATE enrichment class registration is currently taking place and classes will begin in mid-October.

Mr. Kenyon will be meeting with Ms. Logan and Mr. Goines to review the board committees.
